

PARTICIPANTS' RELEASE AND WAIVER FOR FITCH PARK PRODUCTIONS, LLC

PLEASE READ THIS FORM CAREFULLY, and be aware that in signing up and participating in Fitch Park Productions LLC's exercise charity event (hereinafter referred to as "FITCH PARK") between the boundaries of Oak Street (North), Hudson Avenue (West), Sedgwick Street (East) and Locust Street (South), Chicago, Illinois (the "Property") on July 29, 2023, and using the facilities and equipment associated with the FITCH PARK, you will be WAIVING AND RELEASING any and all claims for injuries or loss or property damage that you or your minor child(ren) might sustain arising in any manner out of the FITCH PARK or use of the facilities or equipment. This form must be signed by each adult participant, and by each minor participant's parent or legal guardian, or the participant is not allowed to participate.

Voluntary Participation -I understand that I and/or my minor child(ren) listed below will be participating in the FITCH PARK activities at my/our own risk, and hereby consent to such participation. I attest that I and/or my minor child(ren) am physically fit and prepared for this event. I will not create, or permit my minor children to create, an unsafe situation for other individuals or myself nor use any equipment in any manner inconsistent with its intended use or engage in any activity with which I am not completely comfortable. I will abide by all applicable federal, state and local laws, as well as the rules and directions of the FITCH PARK and avoid any situation that is unsafe. I understand that the Chicago Housing Authority is not sponsoring or providing transportation to this event, but only providing the limited use of its premises.

Waiver of Claim for Injury -I do hereby agree to waive and relinquish all claims against the Chicago Housing Authority, the property manager for the Property, and the FITCH PARK, their respective commissioners, officers, agents, servants, employees and affiliates that I and/or my minor child(ren) may have or sustain for injuries or damages as a result of participating in the FITCH PARK, or using the facilities, premises or equipment in any manner or connection whatsoever, directly or indirectly.

Release from Liability -I hereby fully release on behalf of myself, my heirs, and assigns and discharge the Chicago Housing Authority, the property manager for the Property, the FITCH PARK, and their respective commissioners, officers, agents, servants, employees and affiliates, from any and all claims for injuries, death, property damage, or loss which I or my minor child(ren) may have, or which may accrue to me or my minor child(ren) in the future arising out of participation in the FITCH PARK or the use of the facilities or premises (in any manner or connection whatsoever, directly or indirectly).

Indemnity and Defense -On behalf of myself, as well as my minor child(ren) and respective heirs, executors, administrators and assigns, I hereby agree to indemnify and hold harmless, and defend the Chicago Housing Authority, its property management company, the FITCH PARK, along with their respective commissioners, officers, directors, agencies, employees, contractors, successors and assigns, from any and all claims from anyone resulting from damages, losses, and expenses, including, without limitation, court costs and attorneys fees incurred, arising out of or connected in any way with my participation, or the participation of my minor child(ren) in the FITCH PARK.

Finally, I hereby grant the Chicago Housing Authority, the property manager for the Property, and the FITCH PARK full and complete permission to use photographs, videos and/or comment or quotations of myself and my minor participating child(ren) for legitimate promotional purposes, including marketing materials regarding the Chicago Housing Authority.
